July 2013 Updates and Key Accomplishments

What is the Training & Certification Program?

The Indiana Conservation Partnership's (ICP) Training and **Certification Program** (TCP) strives to improve efficiency in training amongst all technical employees, resulting in a more highly skilled workforce and seamless delivery to customers. The joint move towards a more standardized training. certification and development program was formalized by an **ICP** Agreement in September 2010. Partners also showed full support for the program as outlined in the 2013 Cooperative Working Agreement. Any employee trained and certified through this program will be recognized as competent by every agency in the ICP.



UPCOMING 2013 TRAININGS

Based on the training requests of over 300 Partnership employees, four key training needs were selected as "priority": cover crops, RUSLE2, Nutrient Management, & "Urban" trainings. In 2013, the ICP TCP will focus on Nutrient Management and "Urban" trainings. More information will be available soon. Nutrient Management: a basic nutrient management course will be offered at the Daniels Turf Center in West Lafayette (July 30), Wabash (August 1), SEPAC Butlerville (August 6), & Vincennes University Jasper Campus (August 7.) The course is being developed in conjunction with Professor Brad Joern of Purdue University's Department of Agronomy and Tony Bailey, NRCS . Topics include interpreting soil tests, fertilizer recommendations based on soil tests, nutrient cycling, BMPs for nutrient management in cropping systems and nutrient management associated with specialty crops. **Urban:** featuring Rusty

Schmidt, basic courses will be offered focusing on the basics



of rain gardens, plant selection and considerations, and more. This training will be hosted during the week of October 21-25. Five sessions will be offered across the state: Elkhart Co SWCD (October 21), Clark Co SWCD (October 22&23), Hancock Co SWCD (October 24) & Southwest (October 25).

UPDATES FROM THE COORDINATOR

Greetings! I hope you're enjoying your summer and also getting a lot of conservation on the ground around our state. Most of my time recently with the ICP Training and Certification Program has been spent trying to secure future funding to continue and improve our efforts. First, we applied for a \$100K NRCS Conservation Innovation Grant (CIG). Our pre-application was approved, and we were asked to submit a full application. In tandem, the State Soil Conservation Board (SSCB) granted us \$25k to be used as

cash match towards this grant. Even if the CIG isn't funded, we'll still use the SSCB funds for upcoming trainings. Finally, we applied for a \$75k Sustainable Agriculture **Research and Education** grant. Besides grantwriting, I've been focusing my time on trainings. We're planning upcoming nutrient management and raingarden trainings, and I've also been coordinating efforts with the **Conservation Cropping** Systems Initiative where our program goals overlap. The four RUSLE2 trainings are complete, and next we'll host one for state leaders in Indianapolis. Finally, I'm pleased to report that about half of the attendees at NRCS Boot Camp are Partners (other half NRCS). It's great we're getting participation from several agencies. EMPLOYEE TRAINING NEEDS LIST UPDATED

In early 2013, the ICP updated its "Individual Development Inventory". New and newer ICP employees were surveyed to determine their current technical training needs. Former employees were also removed from the list. (Current employees who submitted this information in 2011 were NOT asked to resubmit any information.) Overall, this led to an update of roughly 70 employees. This updated information will be used to review current ICP training needs. One interesting item to note: in 2011, "cover crops" ranked as the 9th highest training request, but it's fallen to 25. This could be an indication of all of the quality training offered around the state. Great job Indiana! A complete overhaul of the inventory will take place in 2014.
